Curriculum and Credit Hours

Candidates in the Curriculum, Instruction and Assessment program complete a minimum of 30 credit hours of coursework. This is not a cohort program so individuals can earn the degree at their own pace. A working teacher can generally earn this degree in two years.

Admission Requirements

Students applying for admission must meet both the general requirements for admission to all graduate programs and the specific requirements of the particular program of study. The Curriculum, Instruction and Assessment admission requirements are as follows:

- Application for Graduate Studies, including an essay of 500-1,000 words. Application may be submitted at ursuline.edu/apply.
- 2. All official transcript(s) for baccalaureate degree from an accredited institution and any additional undergraduate or graduate academic coursework whether or not credit was earned, the program was completed, or the credit appears as transfer credit on another transcript. Transcript(s) must be forwarded to the Office of Graduate Admission directly by the issuing institution.
- Evidence of ability to do graduate work as indicated by a recommended 3.0 GPA shown on the applicant's transcript(s). At the discretion of the dean, students may be admitted conditionally if their GPA is below 3.0.
- 4. Three recommendations utilizing the required recommendation form. Recommendations should be written by appropriate professionals attesting to the suitability of the applicant for graduate work in the particular field.
- Satisfactory completion of an interview with the program director and/or graduate faculty.

International Students

International students, in addition to the above criteria, must also comply with Ursuline College's procedures for admission as an international student. Visit **ursuline.edu/international** for more information.

Application Deadline

Applicants are urged to initiate formal application as far as possible in advance of the semester or term in which they plan to enroll. Curriculum, Instruction and Assessment courses begin in the fall, spring and summer semesters.
